ORDER

In exercising the powers conferred under Section 3 of the Kerala State Commission for Minorities Ordinance (37/2013), Government as per the Order read as 1<sup>st</sup> paper above, the Kerala State Commission for Minorities has been constituted with a Chairman, two members and a Member Secretary. As per the Kerala State Commission for Minorities Ordinance- 2013, the Chairman and Members are deemed to be public servants entitled to pay and other allowances. Their status, salary and other allowances have not yet been fixed.

2). As per the letter read as 2<sup>nd</sup> paper above, The Member Secretary has requested to fix the status, pay and allowances of the Chairman and Members of Kerala State Commission for Minorities as equivalent to those of Chief Secretary to Government.

3). Government have examined the matter in detail and are pleased to order that the Chairman, Kerala State Commission for Minorities will be given the status, salary and other allowances equivalent to that of Chief Secretary to Government and members of the Commission will be given the status, salary and other allowances equivalent to that of Principal Secretary to Government, subject to the condition that any pension in respect of any previous Government Service or the amount of the honorarium/salary for other services if any being received by the Chairman and members will be reduced from that proposed salary.
